Enrollment Process

Upon receiving this enrollment form, ClearVu will email a "**Member Location Form**" to the contact listed on page one of this agreement. The contact is asked to review the listing of school buildings and or receiving locations to verify them for accuracy. Please make any corrections needed on the Excel form. On the right side of the form, please enter your "**Distributor Customer Number**" for each location listed. This identifying number is used by our team when requesting your electronic purchase data from your distributor. Using this number assures the data is accurate.

Once the Member Location Form is returned to ClearVu, our team will contact your distributors to obtain your electronic purchase data. Some distributors may require additional paperwork to support your participation and we will contact you if this is the case. Enrollment will take several months as the data receiving and other processes are completed. Typically, the first check made out to your district will arrive the fourth month following submission of the Member Location Form. Afterward, a check will be sent monthly.

Once checks begin to arrive, ClearVu encourages you to register for a username and password to access the Member Portal. You can request access when clicking on the member portal button on the upper right section of the website. There you will see an option to register for the site. Once you have registered, you will have access to members only content, and reporting showing your purchases, rebates and other information designed to enable you with a ClearVu of your procurement activity.
